## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**DANGER:** Corrosive, causes irreversible eye damage. Do not get into eyes, on skin or on clothing. Wear face shield or goggles, long pants, long-sleeved shirt, shoes, socks and chemical resistant gloves when mixing, loading or applying this product. Harmful or fatal if swallowed.

### ENVIRONMENTAL HAZARDS

This product is toxic to aquatic invertebrates. Drift or runoff may adversely affect aquatic invertebrates and nontarget plants. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters.

### Groundwater Contamination:

Most cases of groundwater contamination involving phenoxy herbicides such as 2,4-D and MCPP have been associated with mixing/loading and disposal sites. Caution should be exercised when handling 2,4-D and MCPP pesticides at such sites to prevent contamination of groundwater supplies. Use of closed systems for mixing or transferring this pesticide will reduce the probability of spills. Placement of the mixing/loading equipment on an impervious pad to contain spills will help prevent groundwater contamination.

### Cleaning of Equipment:

When cleaning equipment, do not pour the washwater on the ground; spray or drain over a large area away from wells and other water sources. Do not apply when weather conditions favor drift away from target area. Do not contaminate domestic or irrigation waters.

**USE PRECAUTIONS**

Avoid drift of spray mist to vegetables, flowers, ornamentals, shrubs, trees and other desirable plants. Do not pour spray solutions near these plants. Do not spray on carpetgrass, dichondra nor on lawns or turf where desirable clovers are present. Use only lawn-type sprayers. Coarse sprays are less likely to "wind-drift." Use coarse spray droplets. Avoid fine mists. Do not spray roots of ornamentals and trees. Do not exceed specified dosages for any area; be particularly careful within the dripline of tree and other ornamental species. Do not apply to newly seeded grasses until well established. Do not spray when air temperature exceeds 85°F. Seed can be safely sown 3 to 4 weeks after application at recommended rate. After using this product, clean sprayer with soap or detergent and water, and rinse thoroughly before applying other pesticides. Failure to observe the above precautions may result in injury.

**ORNAMENTAL LAWNS & TURF**

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

Do not apply this product through any type of irrigation system. Do not allow people (other than applicator) or pets on treatment area during application.

The maximum number of broadcast applications per treatment site is 2 per year.

**Kentucky Bluegrass, Fescue spp., Perennial Ryegrass, Bermudagrass and Zoysiagrass**

Apply 3 to 4 pints of MEC AMINE-D per acre with spray volumes ranging from 20 to 220 gallons per acre. The equivalent application rate would be 1.1 to 1.5 fluid ounces of MEC AMINE-D per 1,000 sq. ft. with spray volumes ranging from 0.5 to 5 gallons per 1,000 sq. ft. of turf. For mature weeds, apply 3.25 to 4 pints of MEC AMINE-D per acre.

**Cool Season Grasses**

Use MEC AMINE-D at the rate of 3 to 4 pints per acre.

gle nozzle sprayer rather than a multiple nozzle boom as sideways application with a boom where the spray from more than one nozzle is allowed to fall on the same area will result in heavy local over-application and subsequent turf discoloration or injury.
